  - i. B.Sc Nursing Generic (Four Years) Or
  - ii. Diploma in General Nursing and Midwifery.(Preference will be given to the graduate of Government Institutions)

2. The provincial quotas will be observed @ 2% for Minority and 2% for Disabled Persons wherever applicable.
3. General age relaxation in upper age limit for general candidates - 8 years and for special / disabled persons - 15 years.
4. The continuous service in public sector organization rendered by the candidate will be deducted from the age.
5. Disabled/special persons will attach proof of registration with the Social Welfare Department alongwith Disability Certificate issued by the District Standing Medical Board.

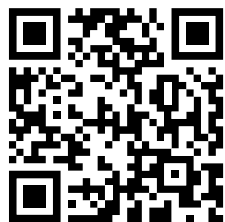
### Eligibility Criteria:
