- 1. The above positions are being offered on Contract basis (extendable subject to satisfactory performance) under the Contract Appointment Policy 2004 (revised 2016) of the Government of the Punjab.

- 3. Incomplete applications or applications carrying incorrect information shall be rejected.
- 4. By hand / courier / post applications will not be entertained.
- 5. Candidates having domicile of Punjab shall only be eligible to apply.
- 6. General age relaxation in upper age limit for male candidate = 5 years, for female candidates = 8 years, special / disable candidate = 15 years and age relaxation of candidates working in public sector organization will be as per current Government policy.
- 7. Transgender are encouraged to apply.
- 8. These vacancies are Post-Specific and Non-transferable.
