## Job Description/Terms of Reference/Qualification requirements for Consultant

### 1. Consultant Case Manager

Implement a process that ensures positive outcomes through ongoing monitoring of progress toward Department goals by:

- Identify and conduct outreach clients in collaboration with NGOs, VCCT and LHWs.
- Maintain coordination with all relevant stakeholders at district level for the implementation of PPTCT activities.
- Assess the comprehensive needs of the client and caregivers.
- Develop an individual service plan by linking with the service delivery system.
- Monitor service delivery on regular basis.
- Advocacy for clients.
- Regular evaluation and need assessment of clients.
- Regular and close liasing with VCCT Centre and Treatment Centers of concerned hospital.

## 2. Consultant Treatment Follow-up

- Track the record of registered patients.
- Follow-up of patients.
- Maintain the record of delivered medicines / in-stock.
- Prepare and submit reports on daily / weekly / monthly basis.
- Coordinate with Health Information & Service Delivery Unit (HISDU) for development / deployment of automated system for patient registration, medicine record & follow-up.
