SHOW CAUSE NOTICE UNDER SECTION 7(b) READ WITH SECTION 5(1)(a) OF THE PUNJAB EMPLOYEES EFFICIENCY DISCIPLINE AND ACCOUNTABILITY ACT, 2006.

**WHEREAS**, the undersigned as Competent Authority under the Punjab Employees Efficiency, Discipline & Accountability Act 2006 in due consideration of the facts of the case, is of the view that you have committed following "*misconduct*" as defined u/s 2(n) of the Act *ibid*:--

"You were posted at BHU Bhagiari, District Sialkot vide order dated 26.08.2020, but you did not comply with government orders and failed to join duty at your place of posting. As such you remained absent from duty w.e.f 26.08.2020 to 16.07.2021."

- 2. **AND WHEREAS,** the undersigned is of the opinion that it is not necessary to hold an enquiry into the matter, in view of the provisions contained in Section 5(1)(b) of the Act ibid. It is, therefore, proposed to proceed against you under Section 7(b) read with Section 5(1)(a) of the Punjab Employees Efficiency, Discipline and Accountability Act, 2006.
- 3. **NOW, THEREFORE,** you are hereby called upon to show cause in writing **within seven (07) days** of the receipt of this notice as to why one or more penalties as prescribed in Section 4 of the Punjab Employees Efficiency, Discipline and Accountability Act, 2006 may not be imposed upon you.
- 4. Your reply to this show cause notice should reach the undersigned within the said period, failing which it shall be presumed that you have no defense to offer and have admitted the charges.
- 5. In case you desire to consult any record on which the aforesaid charges is based or is relevant to the aforesaid charge, you may do so through prior



arrangement with the office of undersigned (Competent Authority) within seven (07) days from receipt of this notice as provided under Section 7(c) of the Act ibid.
