### APPLICATIONS FOR TRANSFER/ POSTING IN DRUG COURTS, PUNJAB (LAHORE, GUJRANWALA, RAWALPINDI, FAISALABAD, MULTAN & BAHAWALPUR)

The Government of Punjab is empowered under Section 31 of the Drugs Act, 1976 (as amended), to establish Drug Courts. Six (06) Drug Courts (Bahawalpur, Faisalabad, Gujranwala, Lahore, Multan & Rawalpindi) are functioning as trial courts for cases covered under the ambit of Act ibid. Whereas, as per Section 31(2) of the Act ibid, each drug court consists of a Chairman and two members (one from the field of Pharmaceutical and another Medical), having experience of 15 years. In order to maintain the smooth and efficient disposal of cases by the Drug Court, candidates interested in being posted as Members (both Medical & Pharmaceutical) in all six Drug Courts in Punjab are required to submit an expression of interest for posting against the vacant post as per the following criteria;

1.	Member (Medical)	The candidate must be an MBBS preferably with a post-graduation qualification, be registered with the Pakistan Medical & Dental Council, have 15-year professional experience, be a regular employee of BS-18/BS-19 of General Cadre in either the Health & Population Department or the Specialized Healthcare & Medical Education Department, Government of Punjab and have no inquiry status.
2.	Member (Pharmaceutical)	The candidate must be a pharmacist preferably with a post-graduation qualification, be registered with the Pakistan Pharmacy Council, have 15-year professional experience, be a regular employee of BS-18/BS-19 in either the Health & Population Department or the Specialized Healthcare & Medical Education Department, Government of Punjab, and have no inquiry status.
